

On August 11, 2006, following the conclusion of the Pre-Trial Review Hearing, the Court considered the Defendant's *Motion for Reconsideration* as to the Court's Order related to the State's motion seeking to transfer the Defendant out of the Forsyth County jail. The Court's Order filed on June 13, 2006 shall remain unchanged except that given the January 2007 trial date, the Court will permit the Defendant to be transferred to the Forsyth County jail from the State penal institution on November 6, 2006. The Sheriff of Forsyth County shall then have the discretion to house the Defendant in Forsyth County or seek to house the Defendant in Dawson County. Should the Defendant not be accepted for housing in Dawson County, the Defendant shall be housed in Forsyth County from November 6, 2006, until further order of this Court.

Defense counsel shall prepare a production order to effectuate the transfer of the Defendant from the state penal institution to the county jail on November 6, 2006.
