
On October 30, 2006, the Court issued an *Order to Draw Trial Jurors*. As a result of said *Order*, numerous jurors who have been summoned pursuant to the requirements of O.C.G.A. § 15-12-65(b) have requested to be deferred and/or excused from the trial of the above-styled action.

Considering the Court’s prior ruling on Defendant’s *Motion for Special Venire That Represents a Cross-Section of the Community for Personal Service on Those Jurors Who Do Not Respond to Summons, and for the Court to Determine All Excusals* (Defendant’s Motion Number 81), wherein the Court previously ruled that it would consider all juror deferral requests on the first morning of jury duty and authorized the Clerk of Superior Court to grant deferrals as specifically authorized by O.C.G.A. §§ 15-12-1(a)(2), 15-12-1(a)(3), 15-12-1(b), and 38-2-276, upon further review, the Court has determined that it is necessary to conduct hearings related to the deferral and excusal requests prior to the first day of jury duty.

On that date, the Court will also review the list of trial jurors and identify those which have failed to acknowledge receipt of *Jury Summons* and discuss with counsel plans for personal service by Deputy Sheriff prior to the first day of trial.

Accordingly, the Court hereby notices counsel that a hearing on said requests shall occur on **January 3, 2007, at 9:00 o’clock a.m.** in courtroom two (2) of the Forsyth County Superior Court. The Court will notify all summoned jurors who have already requested a deferral and/or excusal as to this hearing date and require their attendance.
